- Currently working in region 2 with OPWDD Services
- Homeless Services discussed
- Family Housing program in Ithaca
- Serenity House in Ithaca – Certified Community Residence Program
- Working on a congregate & scatter site re-integration program
- St. John's is a service provider, not a developer of properties
- Q & A session ensued
  - Topics included the homeless situation, housing and various other possible assistance for Tioga County

- Staff
  - Certified Peer Specialist for Mobile Crisis wasn't retained
  - Leila Squicciarini, CASAC, resigned
  - Brean Schaffer, LMSW starting 2/23/26
  - Clinician for Tioga Central Schools in background check process
  - Currently have 5 vacancies in the clinic
- RFP - Opioid Abatement Settlement Funding
  - Contracts are in process at the county level
- Mobile Crisis
  - Interim designation is for adults only
    - Request sent out on 2/10 to serve children as well
  - Katie Mikulski doing a lot of trainings and attending meetings
- AOT (Assisted Outpatient Treatment) & EVA (Enhanced Voluntary Agreements)
  - State funding received to support an AOT/EVA position
    - Individual will be dedicated to all AOT/EVA matters
- Tioga County Jail
  - Current jail social worker put notice in there
  - Social Worker wants to work for the county
  - Seeking a social worker from Mental Health
- IOCC (Inter-office Coordinating Council) Request Received
  - Concerns about CASA Trinity moving from Tioga County to Chemung County
    - They are still connected with the ASAP Coalition, ASA Subcommittee, in schools, and will continue to provide services
- DFC Grant
  - Given to Public Health for oversight
  - Public health chairing the coalition
  - Everything remains the same
  - Grants are expiring
- 2025 Trend Review
  - Data discussed
  - Update needed
  - Information to be resent after revision
