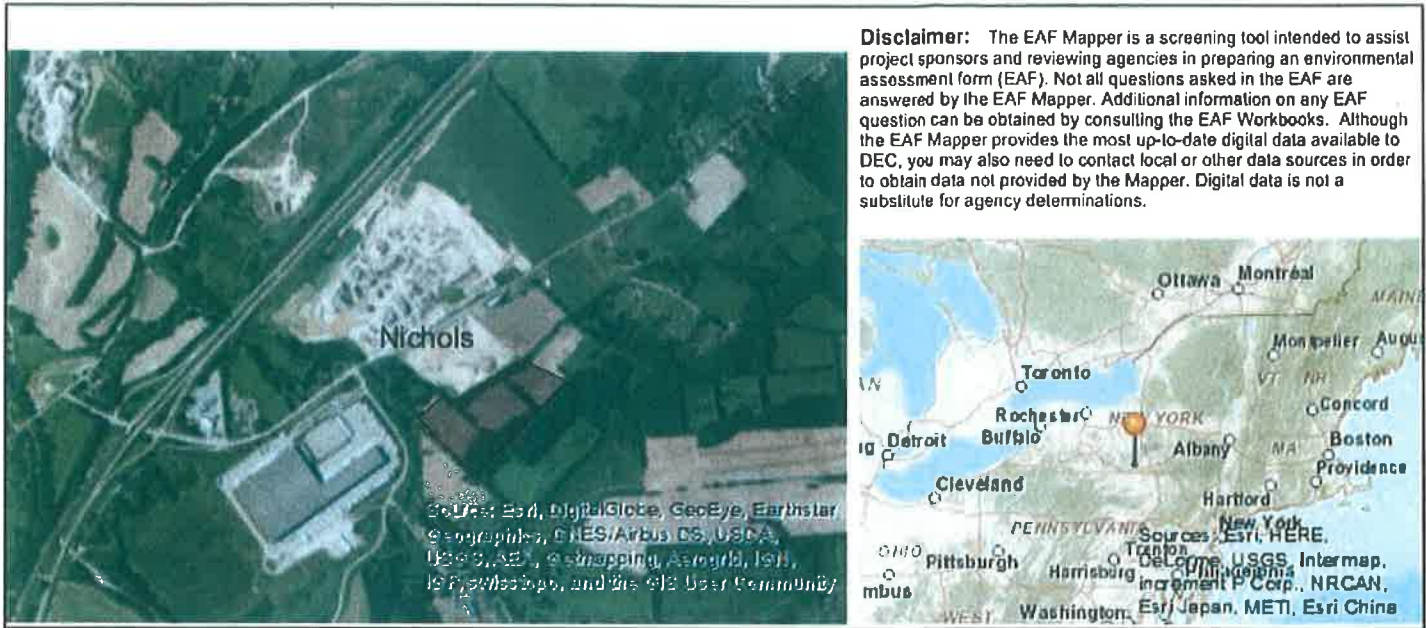

The applicant, Nichols Cross Dock LLC, has completed and submitted a Full EAF Part 1 for the proposed FEDEX Cross Dock facility in the Town of Nichols. Tioga County IDA staff has completed a Full EAF Part 2, based on the EAF Part 1 and information included in the applicant's PILOT application and found that:

- 1) The site is serviced by existing municipal water and sewer which has adequate capacity.
- 2) Erosion control methods will be used during construction to minimize erosion.
- 3) There were no significant historic or prehistoric artifacts found in the archaeological Phase 1A or B investigations.
- 4) The Army Reserve Training Center, a local gravel mining operation, and a Best Buy warehouse distribution center are all in the vicinity making this proposed use in harmony with surrounding area.
- 5) The property that this FEDEX Cross Dock facility will be located on is within a designated Growth Area as mapped in the Town of Nichols 2012 Agricultural & Farmland Protection Plan, so this project will be compatible with this local plan.
- 6) The small wetland on site is under the jurisdiction of the Army Corp of Engineers, so impacts to the wetland will be properly mitigated.
- 7) The impact to the road system is minor with just over 81 truck trips per day anticipated on a county road and state highway that can handle the increase in traffic without any mitigating measures.


