 - Two kits per box
 - Locations: HHS Building, Catholic Charities Women’s Center, Red Door in Waverly, CASA Trinity
 - Working with Public Health for supplies and registering sites
 - Lisa McCafferty would like Security trained
 - Question raised: How are people getting trained? Who will maintain?
 - Information attached to each kit
 - Resource cards included with phone numbers
 - Link to training video

- Person at each location to maintain boxes
 - Agreements to be signed naming the delegated individual at each site
 - Probation interested in a box as well
 - Christina to touch base with Brian Cane
- Legalized Marijuana
 - Opt-In/Opt-Out discussion regarding Tioga County towns/villages
 - Applications received
 - State determining licensures
- Sticker stores
 - Four on Broad Street in Waverly
 - Christina visited and shared her experience
- Pennysaver Article
 - What is allowed and not allowed regarding marijuana
 - Christina to write and run past Shawn Nalepa
- Cannabis Control Board
 - Ashli Mikeska attended
 - Prevention & Education topics avoided
 - Micro-businesses licensed
 - Limited amount for people to grow and sell
