

The demolition and replacement of the Tioga County Clubhouse will have no significant potential environmental impact. The project will be utilizing the existing community water system, and install a new engineered septic system. There are no threatened or endangered species in the area.

The new clubhouse structure will exceed state energy requirements. Since the site has already been operating as a golf course and country club, the use is compatible with the area. There might be slight traffic increases due to in restaurant size, but that increase will be nominal and spread over the course of normal operations, not event-related or episodic in nature.

While this project site is located within a state archaeological sensitive zone, SHPO has made a determination of no impact.

This project will not cause any erosion, flooding, or drainage issues. Stormwater control will be designed and implemented via a Stormwater Pollution Prevention Plan which calls for a permanent infiltration basin practice.

This project will bring a much needed economic boost to the community by infusion of sales tax generated by the new facility.
