The applicant, Tioga Downs, LLC, has completed and submitted a Full EAF Part 1 for the proposed Casino, Hotel and Amenities expansion at their current casino facility in the Town of Nichols. Tioga County IDA staff has completed a Full EAF Part 2, based on the EAF Part 1, the applicant's area variance and special use applications submitted to the Town of Nichols for zoning approvals, and information included in the applicant's PILOT application and found that:

- 1) This use has been present at this site in some form since the 1970's. The current owner has improved the facility and transformed it into an aesthetically pleasing and productive community asset. These plans to further improve the facility will make it an even greater economic asset and benefit to the community. This Tioga Downs facility is supported in pertinent county and local plans, realizing that it is a community asset, and support its growth as a commercial use.
- 2) The site is serviced by existing facility-based water and sanitary sewer systems, which have adequate capacity.
- 3) This project, while located in a prime agricultural soils area, will not be taking or converting any farmland. The farmland owners and operators surrounding the facility have been notified of the project, as the farmland is enrolled in the NYS Agricultural Districts Program through the GML 239 m referral process. No farmland will be impacted.
- 4) The Army Reserve Training Center, a local gravel mining operation, and a Best Buy warehouse distribution center are all in the vicinity making this proposed use in harmony with surrounding area.
- 5) Two small wetlands have been delineated at the extreme west and east side of the property on the north ends. Neither of these wetlands will be impacted.
- 6) A traffic impact study has shown that the existing county road and state highway can handle the increase in traffic and maintain the existing level of service without any mitigating measures.
- 7) Flooding - There are portions of the entire site that are within the 100-year floodplain. No existing or proposed development is in those areas.
- 8) Stormwater - NYS DEC has reviewed and approved a previous SWPPP for the first rendition of this project and determined that no modification is needed for the updated project.
- 8) Tioga County has the endangered Northern Long-Eared Bat, but this project does not entail any tree cutting. Vegetation that will be removed is under the 3 inch threshold.

Therefore this proposed action will have no significant adverse environmental impacts.
