As per Article 6 (Sections 84-90), this letter hereby serves as an Official FOIL Request. It is imperative that ALL questions be answered in depth, fully and within the specified time constraints to avoid legal ramifications outlined in Article 6 (Sections 84-90).

As I am a party to the information being requested, there is no need for redaction or anonymity. The questions or information below ONLY pertain to me personally and my account with the Tioga County Support and Collection Unit. The information being requested is being gathered in an attempt to resolve several conflicts and misunderstandings that the Tioga County Support and Collections Unit has created for itself.

1. Name and title of the highest ranking SCU official?

- A. Name and title of the individual that reviews all petitions and garnishments submitted to any court for accuracy and legality prior to authorizing and submitting?
- B. Name and title of the individual that submitted statements of fact, or other information to any court when seeking a bank account levy or garnishment against me?
- C. Please provide all documentation of court petitions/requests submitted to any court in seeking a levy, garnishment or other seizure of bank accounts, payroll, credit cards and license suspensions etc.

2. Name and title of the judge or administrative official that approved, signed and issued any warrants, court orders or other official documents permitting the TCSCU to levy any bank accounts, licenses or other properties seized against me.

- A. Please provide copies of petitions, warrants, levies and any other internal communications between the SCU Official and the judge or administrative official granting the levy.
- B. Please provide affidavits or other statements pertaining to the amounts to be levied.

1. Example: If there is an arrears of \$500 owed, who makes the decision to submit a statement to the court, under penalty of perjury that the information is factual and accurate, when the official that is submitting the petition requests the court to levy \$1296.57?

C. Please provide the legal basis or the law the official submitting the petition/request to the court to levy or garnish a bank account or other financial seizure for any arbitrary amount including amounts more than DOUBLE the ACTUAL arrears owed. Please provide this law and its UCC number.

4. Please provide the contact information of any, authority that is the oversight authority in Tioga County that monitors and ensures that the Tioga County SCU is performing their duties as outlined in the County policies as well as the Federal Title IV-D policies and procedures?

As of this writing, there has been no response from the Record Officer, the Support and Collection Unit, or the County Clerk. It is assumed that this lack of response constitutes a denial.

This writing; therefore, constitutes my appeal to said denial. As per Article 6 § 89. General provisions relating to access to records; certain cases

4. (a) ... In addition, each agency shall immediately forward to the committee on open government a copy of such appeal when received by the agency and the ensuing determination thereon...

1. Please provide a copy of receipt and any information forwarded to the Committee on Open Government pertaining to the previous request as well as this request.
2. Please provide a copy of the "seal and teste of process" (28 U.S.C. § 1691) documents that any court utilized in the process of granting any Tioga County Officials permission to seize, levy, garnish or otherwise abscond my personal property or finances.
3. Please provide all documentation including name, address and official employed by the process service company utilized to PROPERLY serve notice upon me of the court's intentions that compelled me to enter the court and answer these charges directly prior to any judgment.
4. Please provide any and all hearing notes, evidence submitted and testimony the court heard in making any court order decisions, writs or judgments.

As a courtesy, I will inform this office that it is my belief that this court and other officials acting under the color of law violated my 14th Amendment Rights by committing the crime of "Theft by Taking" without the Due Process of Law as well as other Constitutionally protected Rights. The previous request for information as well as the information requested here is evidentiary by nature and therefore needs to be provided.
