  - Committee to reach out to Jackson Baile for county assistance
  - Process to be set up
  - Lori provided the history of Deputy Director for succession
    - The Board only has control over the Director not the Deputy
    - The Board's objective is to hire a Director
  - The County & Sarah Begeal want to contract with Lori to consult and Lori has agreed
  - A contract will be given to Lori to review
  - Fran sent Lori's resignation letter to the IOCC (Commissioner of all O agencies)

#### Committee Updates

- St. John's Community Services presented at the MH-ASA-OPWDD Subcommittee meeting in January
  - Brian Coleman & Richard Bennett shared St. John's is interested in providing Residential Supportive Housing for Tioga County
  - St. Johns is in other counties
  - Focus would be on missing pieces
  - Housing has been a part of the County Plan for years
  - Board would like St. Johns to present at the February Board meeting

  - Colleen has a conflict due to a mandatory meeting she must attend monthly

#### A New Hope Center – Fran Bialy

- Thank you to the RFP Committee for the funding award
- New RFA – contract helps to keep ANHC moving forward
- 2026 is ANHC 40-year anniversary
  - Planning activities, events and a special dinner in June

#### EMS – Bob Williams

- TAM (Threat Assessment Management) currently has 2 active cases, 2 inactive
  - Process is working well with high participation

- Training coming up in May
- History of TAM reviewed briefly
- Software coming out to track state-wide cases
- All participating organizations working together on cases as whole cases instead of silos
- Tioga County Coroners Association Training at Tioga Downs in the Spring
  - Disaster Mental Health & First Responders Mental Health are part of the agenda
  - Lori noted Sarah Begeal is sending a couple of people to the State DMH training
  - Trainers will be coming here to train the remaining staff later

  - Men's unit is still open but selective
  - Brief discussion ensued
