- We celebrated National Dental Hygiene Month and our Dental staff's combined 57 years on the Mobile Dental Van serving Tioga County residents.
- A representative from New York State Department of Health visited the Village of Candor to review the progress of the project and conduct a sanitary survey. While in Tioga County, they also assisted in the annual inspection of Johnson Bulk Water Supply. A meeting for the Candor project was held and the State inspection of the Candor Village well house was reviewed.
- Recognized by Tioga County Property Development Corporation Board for our assistance inspecting and approving an existing septic system for the properties included in Candor's NYMS Project.
- Heather Vroman was nominated as Employee of the Third Quarter!
- We fully reconciled with the Tioga County Treasurer through 2021 for Accounts Receivables.
- Attended the Tioga Opportunities Older Adult Health Fair, and Trunk or Treat events at Health and Human Services Building and Nichols Fire Department.
- Coordinated getting polio postcards and magnets delivered to elementary schools.
- The Dental van visited Elm and Lincoln St Elementary Schools in Waverly. Over 250 Waverly School students received dental services during our visit.
- We hosted a water Operator Training at the end of September.
- Partnered with Stray Haven in hosting a Rabies Clinic, over 150 animals were vaccinated!
- Katie W. completed Safe Specimen Packing and Shipping Training; Kim, Janice and Nicole completed CPR training with Roy Schreiner.
- Lisa M. attended the NYSACHO Public Health Leadership Summit. Dan attended the Central New York Regional Environmental Health meeting which reviewed a regulatory update on the Bureau of Water Supply Protection and new grant programs for Drinking Water State Revolving Fund, Water Infrastructure Improvement Act and Intermunicipal Grants.
- We said goodbye to Angel Conklin and wished her well on her next endeavor down south.

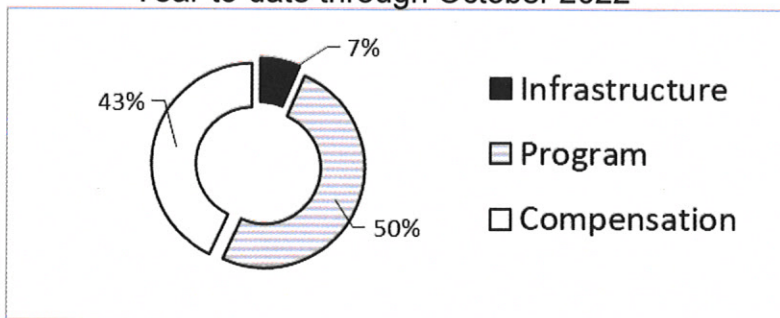

  2. During 2020, the Legislature required a 10% cut in expenses from all County departments. This was removed from the Expense side of the ledger, but not the offsetting revenue portion, thus inflating the reported "Local Share" of Public Health by nearly \$375K.
  3. COVID Specific funds have been removed from these tables, as they skew the numbers due to their large amounts. Currently over \$2.6 million has been appropriated of Covid funding within Public Health.

# Guest Column: October is National Dental Hygiene Month

National Dental Hygiene Month serves as a reminder to practice good oral hygiene year-round, but especially during the holiday season when people may be consuming more sugary foods than normal.

While enjoying the occasional treat is acceptable, we need to make sure we are properly caring for our teeth to prevent tooth decay, gum disease, and other

oral complications.

In 2021, over 50% of patients seen for a dental screening on the Tioga County Mobile Dental Van

had some extent of tooth decay.

Dental problems are not only painful, they can negatively impact our overall health by limiting the nutritious foods we can comfortably eat which may lead to malnutrition. Follow these tips for a healthy smile across your lifespan!

For Babies:

- Wipe their gums with a soft, clean cloth twice a day – once in the morning after their first feeding and again before bed.
- When their teeth come in, start brushing them twice a day with soft, small-bristled toothbrush and plain water.
- Schedule a dental visit by your baby's first birthday.
- Talk to their doctor or dentist about putting fluoride varnish on their teeth as soon as their first tooth comes in.

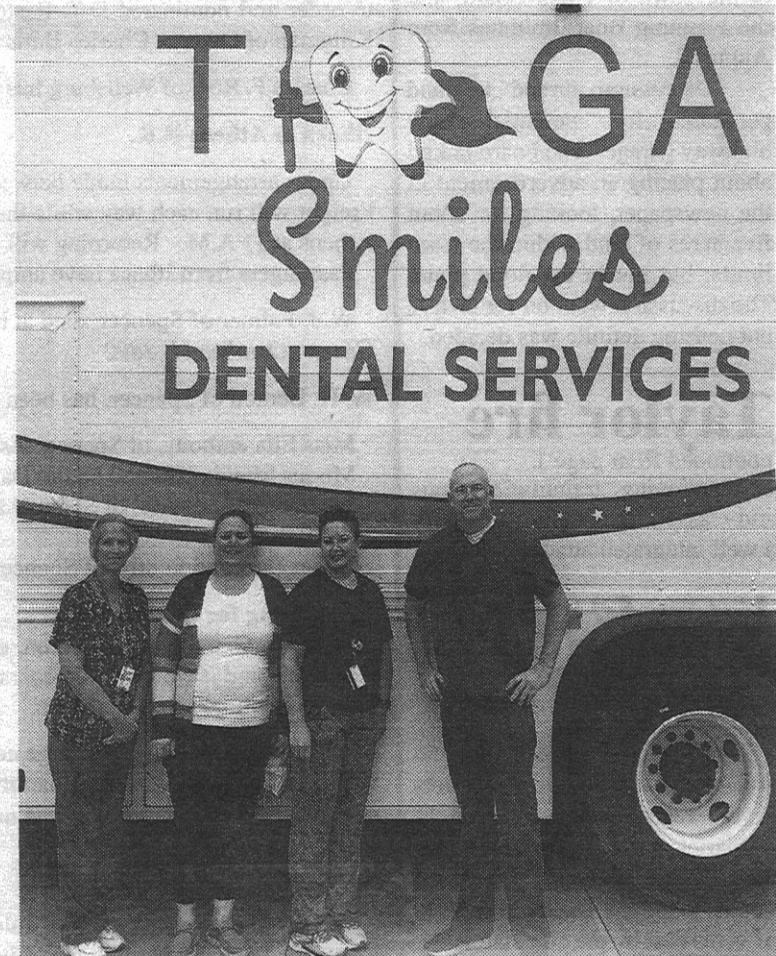

For Children:

- Brush their teeth twice a day with fluoride toothpaste.
- Ask their dentist when they should start flossing.
- Ask your child's dentist to apply sealants, if appropriate.
- Serve them more fresh fruits and vegetables! Limit foods high in processed/added sugar.

For Adults:

- Brush your teeth twice a day and floss daily.
- Visit your dentist regularly, at least 1-2 times per year.
- Do not use tobacco products and limit alcoholic drinks.
- Limit foods high in processed/added sugar (cake, candy, cookies, soda, juice, etc.)
- Control chronic health conditions, like diabetes.

# Legislature Approves Agreement with NY Power Authority for Evolve NY Program

At the Oct. 11 meeting of the Tioga County Legislature a resolution was passed approving an agreement with NY Power Authority (NYPA) for Evolve NY Program. The number of electronic vehicle purchases is increasing in Tioga County and across the country, and EV charging stations can be a tourist draw.

Tioga County Courthouse has 70 parking spots rarely used so NYPA will install and maintain four fast charging EV stations at no cost to Tioga County.

The Village of Owego is willing to pay the county \$500 annually to cover any additional insurance premium for the duration of the 10-year Site Host Agreement.

Tioga County Economic Development and Planning (TCEDP) was approved to create the Education Workforce Coordinator position, funded by way of grant funds and Sean Lanning is appointed to the position of Education Workforce Coordinator. The Hooker Foundation has agreed to provide funds for the position in the amount of \$100,000 annually for over three years.

The legislature approved the Director of Emergency Services' request to enter into an agreement with Onondaga County for Master Site Server Radio Network Service at a cost not to exceed \$43,125 per year for the period of Sept. 1, 2022 through Dec. 31, 2026.

A contract was authorized with Syracuse Time and Alarm Company at an annual cost of \$10,594.

Another contract was also awarded for cleaning services for county buildings to GDI Services in the amount of \$358,208.64.

The Legislature authorized a contract with Excellus Blue Cross/Blue Shield of Central NY to administer health insurance benefits for Tioga County. A contract was also authorized with Lifetime Benefit Solutions, Inc. to administer flexible spending and health reimbursement account programs.

A contract was approved to contract with National Test Systems for instant urine tests and lab testing for the needs of the Tioga County Probation Department.

Vera Lin Layman was appointed Election Commissioner for the Republican Party from Jan. 1, 2023 through Dec. 31, 2024.

The legislature passed a resolution adopting Ag and markets new SEQR short environmental assessment form for agriculture district modifications.

A public hearing has been set on the 2023 budget for Tuesday, Nov. 15 at 10 a.m. in the Hubbard Auditorium.

A proclamation was passed by the legislature proclaiming the week of Oct. 23, 2022 to Oct. 29, 2022 as Lead Poisoning Prevention Week. New York State Public Health Law states all one-to-two-year-olds be tested for lead levels. Between 2019 and 2021 Tioga County Public Health provided case management and environmental health

services to 30 children with elevated blood lead levels.

A resolution was passed recognizing David Ayres for his 33 years of dedicated service to Tioga County.

# Back to learning

## Waverly school officials break down COVID policy, stimulus usage

WAVERLY — During its latest school board meeting Thursday, Waverly Central School District officials explained the district's updated COVID response plan, and how they spent the dollars allocated to the district from the various COVID stimulus funds.

Director of Curriculum and Instruction Elizabeth McIntosh explained that students who test positive for COVID-19 will be sent home for five days, and a mask will be required for five days upon their return to school. All other masking is optional.

Additionally, McIntosh encouraged any students who are experiencing COVID-like symptoms to get tested promptly, and to stay home if they're not feeling well. She noted that testing kits are available in the nurse's office.

Superintendent Dr. Eric Knolles added that remote learning will only be utilized as an emergency option if required by the Tioga County Department of Health.

As for the pandemic stimulus funds, McIntosh said the district received financial relief in the form of three different sources — the CARES Act, CRRSA Act and the ARP ESSR Fund.

While the funding from the CARES Act has now closed, McIntosh

explained how the district spent the over \$1.3 million from CRRSA and the \$1.1 million and the \$2.97 million allocations from the ARP ESSR fund.

"We looked at sustainable ways to spend the money," she said. "Because the expectation is that these funds won't be replenished down the road."

Some of the CRRSA funds were allocated for positions, such as a social studies teacher, guidance counselor, speech language pathologist, special education teacher and director of management services, while other items included professional development, iPads for students and a Jeep Cherokee for transporting students.

"Lots of professional development," McIntosh said. "And transportation is always an issue for our kids, especially in the winter when access can become an issue."

The smaller chunk of the ARP ESSR funding was spent similarly — such as professional development and learning tools like STEM Scopes kits and a core phonics program — but the larger block of ARP ESSR monies saw much more diversity in terms of how it was spent.

In addition to more professional development and partial funding for several positions, items such as computer stations, water bottle filling stations, air filters, laptops, and furniture for the Chemung Innovation Center were purchased using the money. Additionally, the popular Winner's Circle program, in which students construct a race car, was funded through the ARP ESSR.

Dear Editor,  
New York State (NYS) data show that some people who have insurance and a doctor are not getting preventive care, such as breast cancer screening. This month the New York State Department of Health released data from a 2020 survey of women ages 50-74 years that asks if they have had a mammogram within the past two years (Behavioral Risk Factor Surveillance System). It is surprising that most women who said no had insurance (nearly 92%) and a regular healthcare provider (almost 85%).

One barrier may be a lack of paid time off from work for cancer screening. Without paid time off, an employee may have to choose between a potential life-saving screening and

the paycheck on which she and her family rely.

For Breast Cancer Awareness Month, the Cancer Prevention in Action Program is encouraging employers to help their employees stay up-to-date with mammograms by adding a paid time off benefit for cancer screenings.

Research has shown that offering specific time off for cancer screening (not sick or vacation time) increases employee screening rates. Studies also show that employers who offer paid time off for cancer screening have a healthier workforce. This is because staff is encouraged to make regular healthcare visits. In addition, employer savings related to finding cancer early essentially pays for the costs of provid-

ing paid time off for cancer screenings.

# Trick-or-Treat Safety

Did you know that, on average, children are more than twice as likely to be hit by a car and killed on Halloween than on any other day of the year? This is primarily due to lack of visibility due to low lighting.

Take these precautions to get the most "treat" out of Trick-or-Treat.

## **Walk Safely**

Cross the street at corners, using traffic signals and cross walks; look left, right, and left again when crossing, and keep looking as you cross; put electronic devices down and keep heads up; walk, don't run, across the street; and teach children to make eye contact with drivers before crossing in front of them.

Always walk on sidewalks or paths. If there are no sidewalks, walk facing traffic, as far to the left as

possible. Children should walk on direct routes with the fewest street crossings.

Watch for cars that are turning or backing up. Teach children to never dart out into the street or cross between parked cars.

Children under the age of 12 should not be alone at night without adult supervision. If kids are mature enough to be out without supervision, remind them to stick to familiar areas that are well lit, and trick-or-treat in groups.

## **Costumes**

Decorate costumes and bags with reflective tape or stickers and, if possible, choose light colors. Choose face paint and makeup whenever possible instead of masks, which can obstruct a child's vision.

Always test makeup in a

small area first to see if irritation develops. Remove all makeup before children go to bed to prevent skin and eye irritation.

Have kids carry glow sticks or flashlights to help them see and be seen by drivers. When selecting a costume, make sure it is the right size to prevent trips and falls.

## **Drive with Extra Caution**

Slow down and be especially alert in residential neighborhoods. Children are excited when trick-or-treating and may move in unpredictable ways. Take extra time to look for kids at intersections, on medians, and on curbs.

Enter and exit driveways and alleys slowly and carefully. Eliminate any distractions inside your car so you can concentrate on the road and your surroundings. Drive slowly, anticipate heavy pedestrian traffic, and turn your headlights on earlier in the day to spot children from greater distances.

Popular trick-or-treating hours are 5:30 p.m. to 9:30 p.m., so be especially alert for kids during those hours.

**1 IN 6 BREAST CANCERS OCCUR IN WOMEN AGES 40-49.**

**Know the signs:**

- Red, swollen or tender breast
- Lump or change in the breast
- Dimple or puckering in the skin of the breast
- Fluid or discharge, other than breast milk, from the nipple
- A lump in the underarm area
- Nipple inversion (turning inward)

# Breast Cancer Awareness

### Lower Your Risk!

Maintain a healthy weight.  
Exercise regularly.  
Limit alcohol to one drink per day.  
Breast-feed your children, if possible.

If you have a family history of breast cancer or inherited changes in your BRCA1 and/or BRCA2 genes, talk with your provider about other ways to lower your risk.

### Warning Signs of Breast Cancer

- A lump or mass in the breast or axilla
- Thickening or swelling of the breast
- Change in the size, shape, or color of the breast
- Change in the way the breast feels
- Change in the way the breast looks
- Change in the way the breast feels

### Get Screened!

Get the recommended best way to detect breast cancer early, when it's easier to treat.

Screening only can detect breast cancer if it is caught early, or cause symptoms.

Women who are at average risk can start at 40-74 years old and have a mammogram every 2 years.

Women with a family history of breast cancer or other factors may benefit from starting mammography at the age 30.



WHEREAS: Tioga County has need for chairs at the Ronald E. Dougherty County Office Building (RDCOB); and

WHEREAS: TCPH has discussed and agreed with both the Commissioner of Public Works and the Chair of the Legislature, a plan to purchase new chairs and transfer their current chairs to RDCOB; and

WHEREAS: TCPH has funding that will partially reimburse the cost of new chairs if purchased by and for TCPH; and

WHEREAS: TCPH has funds available for this purchase in their 2022 budget, yet requires transfer to appropriate budget lines; and

WHEREAS: Amending of Budget and Transfer of Funds requires Legislative approval; therefore be it

RESOLVED: That funding be transferred and appropriated as follows:

**COUNTY OF TIOGA  
EXECUTIVE PROCLAMATION**

WHEREAS: Hunting is an American tradition, and among the most popular forms of outdoor recreation; and

WHEREAS: Tioga County is rich in wooded land, making it highly suitable for hunting; and

WHEREAS: During the 2020-2021 sporting season, 16,294 sporting licenses were sold to residents and non-residents in Tioga County, an increase of almost 5,000 in the previous two years; and

WHEREAS: Hunting may include the harvesting of big and small game animals by firearm, bow-and-arrow and trapping. A total of 7,208 deer, 583 turkey and 13 bear were harvested in Tioga County in 2020 and 2021; and

WHEREAS: Hunting is typically an enjoyable sport, but tragically in 2019 there was an accidental shooting related to hunting in Tioga County, that was preventable; and

WHEREAS: 2021 had the lowest number of hunting-related shooting incidents ever recorded in NYS, but efforts to reduce hunting accidents and promote safe hunting must continue; and

WHEREAS: Every new hunter must take a hunter education course, that teaches future hunters how to be safe, responsible and ethical in the field; and

WHEREAS: Every hunter, whether new or experienced should always follow basic hunter safety standards: let someone know where you will be hunting and when you plan to return, practice shooting and check all equipment to ensure it's in good condition, wear hunter orange or pink in the field, treat every firearm as if it's loaded at all times, identify your target before shooting, and

WHEREAS: Check if maintenance is needed on tree stands in advance, wear a safety harness if hunting from a tree, know the limitations of your physical ability and your equipment and do not push them; and

WHEREAS: Hunting is a privilege and all hunters have a responsibility to know the laws and regulations, but also have a duty to keep themselves and their fellow hunters safe; therefore

The TIOGA COUNTY LEGISLATURE, County of Tioga, does hereby proclaim the month of November as

**HUNTING SAFETY MONTH**

and urges all those who hunt to participate in hunter safety education, and follow basic hunter safety standards to prevent hunting-related accidents and deaths.
